SECTION 3 - HAZARDS IDENTIFICATION

SECTION 6 - ACCIDENTAL RELEASE MEASURES

Personnel Precautions:	Evacuate area and keep unnecessary and unprotected personnel from entering the spill area.
Environmental Precautions:	Avoid runoff into storm sewers, ditches, and waterways.
Spill Cleanup Measures:	Absorb spill with inert material (e,g., dry sand or earth), then place in a chemical waste container. Provide ventilation.
