4. FIRST AID MEASURES

Inhalation: Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give artificial respiration. If symptoms

persist, get medical attention.

Skin contact: Immediately wash with soap and water. Remove contaminated clothing and shoes. Wash clothing before reuse.

Eye contact: Immediately flush with large amounts of water for at least 15 minutes. Get medical attention.

5. FIRE-FIGHTING MEASURES

Extinguishing media: Foam, water spray or fog, dry chemical or carbon dioxide.

6. ACCIDENTAL RELEASE MEASURES

Use personal protection equipment recommended in section 8, isolate the hazard area and deny entry to unnecessary and unprotected personnel.

Environmental precautions: Prevent product from entering drains or waterways.

Clean-up methods: Remove all sources of ignition. Evacuate area. Dyke spill to prevent from entering water

ways. Ventilate area. Wear protective equipment to clean up. Soak up spill using absorbent material such as sand, silica gel, acid binder, universal binder, or saw dust. Scrape as much material as possible and store in partially filled container until disposal.

7. HANDLING AND STORAGE
